Discussion of Bike Path: The committee discussed and looked at the map again to place the tentative route on the map. Dan Nolan thought before the next meeting to have a few areas as review areas. One would be in front of the high school and another in front of the sewer plant. Frank Ottengheime asked about running the bike path along the south side through the trees in the park. It may eliminate some of the issues with the ditch and going around the sewer plant. There was discussion of having to cross the road again may be an issue.

Wendy Schnorr let the committee know there will be a conference starting on Oct. 27, 2013 from Rails to Trails in Matteson. Wendy said she may be able to go.
