Approval of Minutes from August 13, 2022 Meeting: Mark Cinnamon motioned to approve the minutes, Jen Morrison seconded. All in favor voted aye. Motion carried.

Treasurer’s Report: Jim Johnson reported a correction on the report. Included a payment from Paypal that occurred in April 2021. The Squarespace rate will increase from \$99.00 to \$120.00 but won’t be due until December. All in favor voted aye. Jen Morrison motioned to approve Treasurer’s Report, Mark Cinnamon seconded. All in favor voted aye. Motion carried.

Bills: Jen Morrison motion to approve paying \$120.00 for Squarespace when it is due. Mark Cinnamon seconded.

Grant Report: Jim Johnson report the plan was to apply for a grant to finish the pathway. Jim contacted Bruce Novak and is now not willing to commit to put the path on his land. Bruce proposed other routes for the path, but they were not feasible or did not connect to all of the locations. Will not go ahead with the application at this time. NICOR has said we can go past them but not over them on the path. Jim had a discussion with Joe Linkitus to clean up the brush between the parking lot and Shabbona Road in order to put in a temporary path. Discussed other options for the pathway.

NICE walk: Next Saturday is the walk. Dan will talk to the fire department about having some lights at the corner of Route 30 and Indian Road to slow down traffic.

Dan reported attending the development committee meeting with the Potawatomie. Frank Ottengheime will be stepping down on the pathway committee, the new fire chief will be notifying Dan of a replacement soon.

Next pathway meeting is October 8, 2022 at the Chief Shabbona Forest Preserve weather permitting.
